I. Legal Actions

- PERB Improper Practice (IP) Against District – October 18, 2018 Refusal to Allow Union Reps (LRS's) to be Present with Teachers – McKinley and Performing Arts
- PERB – School 59 “Strike”, November 14-15, Action Against BTF
- Court – Article 78, School 59 “Strike”, November 16, Action Against District – Deduction of Penalties, 2/1 - Some - \$700.00 from 1st Check – No Hearing
- Court Confirm Arbitration Win – November 29, City Honors Found to Harm Students' Education , Reprisals Against Teachers
- I.P. Against District – October, Receivership Schools – District Did Not Allow BTF to Introduce Class Size Proposal in Receivership “Negotiations” – We Want All Past District Receivership Proposals Null and Void and New Negotiations For Current Schools
- Court – Overturn Arbitration – October 24, 2018 – District did not have to pay some teacher overages, Alternative School
- PERB – Improper Practice Against District – Not Following Grievance Timelines – First Conference Held October 18, Awaiting Next Scheduled Conference Date – Mediation with District to Be Held October 29 – Attempt to Resolve Some Arbitrations
