It is an honor to work for, fight for and represent the finest, most dedicated teachers anywhere.

What you have done and continue to do for your students, during these stressful and dangerous times, shows a commitment few understand.

We have accomplished much together:

- Legal and public actions had many safety concerns addressed. We have many more to address.
- We obtained funding to ensure safety in our schools/sites.
- We prevented attempts to roll back critical health and safety protections (social distancing/premature student attendance, etc.).

We will work with others and, if necessary, fight to ensure safe and healthful conditions in our schools/sites. Have no doubt about that.

Once the funding we fought for arrives, negotiations will resume with the Mediator who supported delaying negotiations during the pandemic. We will be fighting for a contract not only like those around us, but better. Together, we made significant strides in our last contract despite spending years going all the way to the U.S. Supreme Court. A battle we had to fight.

We fought off attempts to gut our contract e.g. raise class sizes, cut healthcare benefits, remove healthcare for retirees, provide miniscule salary increases, etc. We:

- eliminated teachers staying on Steps 15, 17, 19, 21 for two years and for Step 13, BS+40 – Dr. We will now further reduce steps to get to maximum.
- have teachers starting on at Step 2,
- increased MS starting salary from \$37,552 to \$44,859,
- increased MS+30 max from \$77,666 to \$96,401,
- prevented paying a percentage of healthcare teachers in surrounding Districts pay 8-10% on average many pay 12-15% or more.

The current yearly costs for the most-used Traditional Plan/s -- \$9,700 single, \$21,491 family.

Some current District "Proposals":

- School year 42 to 44 weeks (4.8%).
- No retiree healthcare after July 1, 2020 Full-time teachers pay 20% toward healthcare.
- Remove delineation of healthcare coverages.
- Co-pay for prescriptions from \$10 generic, \$25 brand name to \$25 generic and \$50 brand name.
- Eliminates waiver pool for teachers covered elsewhere.
- Personal days from 5 to 3.
- Teaching periods from 5 to 6.
- Remove Art, Music, P.E. in K-6.
- Faculty meetings 10 to 20.
- Salary increase 1.5%!!

With our continued undiminished solidarity, we will prevail over all attacks and challenges.

Together, we have made significant progress; however, there is more to accomplish. With your continued solidarity and support, it will be done.
